Community Small Grants Round 2 now Open

Applications close 31 March 2021

In recognition of the pivotal role that community groups and organisations play in developing vibrant and diverse communities, Council is committed to providing support and assistance through the Shire of Three Springs Community Small Grant Program.

The program's objectives are to provide funds of up to \$3,000 to community-based organisations to support social, economic, recreational, art, and cultural benefits. The focus is on assisting groups in delivering the following:

1. Supporting volunteers by building the capacity of local clubs and organisations with small equipment purchases;
2. Support programs, activities and initiatives delivered by community groups;
3. Support community development initiatives;
4. Increasing the range of events, activities, and services within the Shire;
5. Providing mentoring opportunities to community organisations to strengthen their organisation; and
6. Generating local economic activity, tourism and development.

There are three categories available through the Community Small Grant Program. Before commencing an application, please read the Guidelines.

Community Small Grants

Up to \$3,000 - two rounds per annum

This funding assists with funding towards infrastructure and equipment and sponsorship requests in excess of \$250.00. Examples of this type of funding may include events, uniforms or equipment.

Waiving of Fees

Open round - up to \$1,500

Council's Waiving of Fees stream assists with funding programs with a reduction or waiving of Council's fees and charges, including but not limited to community bus use, facility hire, and photocopying. Examples of this type of funding may include Senior Day trips, facility hire for school holiday programs.

Sponsorship

Open round - up to \$250

Council's sponsorship program is to assist with funding towards running events and projects. Examples may include significant events, community workshops, information sessions and school holiday programs and activities.

It may not be love, actually

While there are many success stories of people falling in love after meeting online, there are also some very sad tales involving victims of romance scams.

Australians reported losing more than \$38 million to romance scammers in 2020, the majority of which was lost through social media platforms like Facebook, Instagram and Snapchat. In WA last year, 72 victims reported losing \$2.17 million – an average loss of \$30,000 each.

These figures have prompted consumer protection agencies across Australia to remind people to be cautious and that victims aren't just those who are actively seeking a partner – it could be you, a friend or family member.

Romance scammers will often spend months building up trust before asking for money from their victim, who may agree to send funds because they feel the need is genuine or believe it will be used to buy an airfare so they love-interest can travel to meet them.

But while the victim is feeling loved-up, the scammer becomes cashed-up.

Often these people will use stock images, or images they've taken from someone else's social media, so before engaging online it's important to do a reverse-image search via Google or TinEye.

Always be wary if the person you've met online quickly wants to move communications away from the dating website or app and onto another platform, such as email, Facebook Messenger, WhatsApp or Viber.

If they ask for money, but won't meet in person, that's a big red flag – never give money to someone you haven't met in person.

It's important be careful about the personal information you share, as many romance scam victims not only lose money, but they can also experience fraud, such as discovering new mobile phone accounts set up in their name, or that their superannuation account has been accessed.

Victims of identity theft should contact IDCARE at www.idcare.org or by calling 1300 IDCARE (432273), while people can report scams to the ACCC by visiting www.scamwatch.gov.au/report-a-scam.

If bank account details have already been sent to a scammer, contact your financial institution as soon as possible to stop any further losses.

Cancelling a car contract

Buying a car can be a big expense, so it's worth knowing that after signing on the dotted line there are costs you could be liable to pay if you change your mind or are unable to go through with the deal.

Under the *Motor Vehicle Dealers Act*, a dealer is allowed to charge up to a maximum of 15 per cent of the contract's value as 'pre-estimated liquidated damages'.

The actual amount should represent the true cost of the deal falling through to the business. Unfortunately though, it appears that sometimes this maximum rate is being used as a 'flat rate' in some sections of the industry.

In the past two years, Consumer Protection has received 126 complaints relating to dealers holding deposits or claiming liquidated damages. We were able to resolve more than 80 per cent of those cases, achieving \$107,728 in redress for consumers.

Charging the maximum rate as an automatic default amount is not compliant with the law and dealers should not be charging any more than the reasonably estimated actual cost to the business.

When we query the amount of damages being charged, especially after receiving a complaint, the dealer needs to clearly justify how the damages have been calculated, eg. For vehicle licensing costs, special accessories that may have been fitted and demonstrable administration costs.

The issue highlights the need for buyers to avoid being pressured into signing a purchase contract, as it is a legally binding commitment that could be costly if the contract is cancelled due a change of mind or circumstances.

It's important for consumers to query 'excessive' fees being imposed and, if the explanation is unsatisfactory, demand the charge be waived or reduced.

If the dealer refuses, a complaint can be lodged with Consumer Protection so we can independently assess and attempt to resolve the matter.

Call for new Local Drug Action Teams in Durack

16 February 2021

Community organisations in Durack are being invited to form a partnership to tackle drugs and alcohol, with funding from the Morrison Government.

Federal Member for Durack, the Honourable Minister Price, said applications were now open for registration of new Local Drug Action Teams (LDATs) to prevent and minimise harm from ice, alcohol and other drugs.

“Alcohol and other drugs, including ice or crystal methamphetamine, are issues for communities, not just for individuals,” Ms Price said.

“Community action is effective because many of the factors influencing drug-related harm can only be targeted at the community level, like social connections, education and a sense of belonging,” Ms Price said.

This recruitment round aims to approve 40 new LDATs, which can apply for \$10,000 in initial funding to support prevention and health promotion activities, with further funding available.

There are currently 238 local teams doing great work in all states and territories, who in partnership with the Alcohol and Drug Foundation are developing Community Action Plans to target their local needs.

The LDAT program has received more than \$29 million since it began in 2016 and the Morrison Government has already committed more than \$800 million over four years to reduce the impact of drug and alcohol misuse on individuals, families and communities.

Applications from new LDATs are now open on the LDAT Community Hub: <https://community.adf.org.au> and close on Friday 5 March.

The hub contains extensive information about the program and how to apply and prepare a strong application.

INDUSTRIAL MANSLAUGHTER LEGISLATION **ARE YOU PREPARED?**

In the later part of 2020, the current government passed their new Industrial Manslaughter Legislation. Curiously, the Nationals Party supported this legislation with very little consideration as to how it can be applied to the farming and regional trade industries. An employer can now go to prison if their worker is killed at their place of employment. A simple offence can result in 10 years imprisonment AND a 2.5 million dollar fine. A serious offence may result in 20 years imprisonment AND a 5 million dollar fine. Much more for incorporated bodies.

As a police officer I have had the very unpleasant task of attending and investigating many work place deaths, and then watched all parties go through a harrowing investigation and subsequent Coroner's Inquest. I fully support safe workplace practices, but I have serious concerns that the average 'mum and dad' farming/business operator is not prepared for this legislation. There are so many questions I can think of that need to be answered by Worksafe. Employers for these rural businesses will now need to demonstrate they have conducted inductions, emergency contingency plans, equipment familiarisation, OSH inspections and so on. If I am elected, I will run a series of forums and invite Worksafe, solicitors and sector representatives to ensure everyone knows what is required of them. Otherwise, business owners will find out the hard way if an accident occurs and they don't have these various requirements in place.

I am also seeking feedback on the last round of Work Safe inspections on rural and regional farms (they conducted 21 unannounced inspections). I support safe employment conditions in all sectors but I am keen to ensure this process is also a supportive educational process for these unique business operators

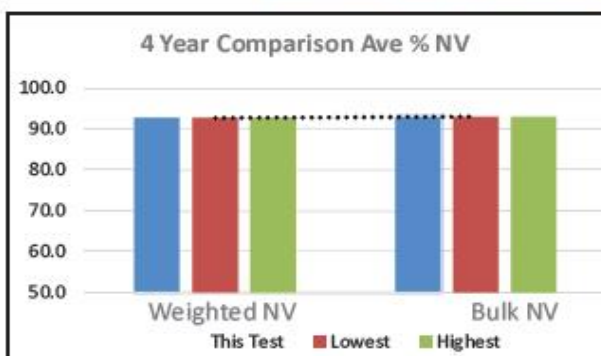
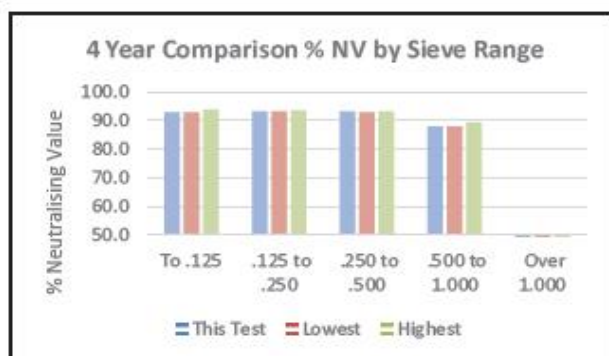

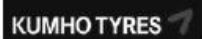
